
## MESSAGE FROM THE CEO

In March 2020, we had to close all 18 of our Day Programs and Art Centers, disrupting the lives and daily services of 430 people. All other programs and services have also been affected and providing critical hands-on supports has become even more difficult and risky for both staff and the people we serve. Most administrative and support staff now work remotely, and our lives seem to be just a series of Zoom meetings!

Although we must follow mandated closures and restrictions, the TURN staff continue to be their best and creative selves as they adapt and rethink the look and feel of services. Individuals and families need extra care and compassion as they face new and frightening circumstances and an unpredictable future. As an administration, we strive to communicate messages of hope and appreciation to our employees. We are grateful to donors who continue to support us while facing their COVID-caused hardships. TURN will get through this challenge, as we always do, and will continue to be "the premier provider of quality services for people with disabilities in Utah!"

TURN Community Services was founded in 1973 in Utah by a group of parents who wanted to improve program services for their adult children with intellectual and developmental disabilities. TURN started by opening residential programs in Ogden and Bountiful, where individuals with disabilities could live and participate in their community and have an integrated, more independent experience. TURN Community Services now provides services to 810 individuals with developmental disabilities in Utah. We provide services throughout the state from Brigham City to St. George. We offer a full range of services, including residential services, art & educational day services, supported employment, family support & respite services, summer camp, mental health counseling, and financial management.




