MESSAGE FROM THE CEO

In 2023, TURN Community Services will celebrate 50 years of serving people with disabilities in Utah. TURN was founded in 1973 to respond to a critical, unmet societal need. At that time, there were no inclusive community services for children or adults with disabilities. Doctors in Utah often advised parents to place their child in the State institution for reasons such as "they will never be able to learn and will not amount to anything" or "they will likely ruin your marriage and your family." Knowing there was a purpose and a future for their children, a group of parents

opened a group home in Ogden, Utah, then in Bountiful, and soon incorporated as a Utah non-profit: Project TURN.


TURN has always existed to meet critical needs and do it exceptionally well while focusing on each individual's unique preferences and circumstances. Comprehensive and preparatory services for students with disabilities transitioning out of high school have always been underfunded and not often available in rural Utah.

In 2020, TURN created a statewide, Director of Employment Services position in preparation for expanding and diversifying our offerings in the employment services realm for youth and adults throughout the state. In October 2021, we received a significant federal grant from the Utah State Office of Rehabilitation to provide Pre-Employment Transition Services (Pre-ETS) to students ages 14-22 served through an IEP or a Section 504. We were awarded a 3-year contract totaling \$2,012,180 to provide Pre-ETS in 24 Utah Counties (nearly the entire state) and were one of the first providers in the nation to receive the grant. Since then, we have hired Employment Services Specialists in most areas of the state and are known as a premier provider of Employment Services in Utah.

Fifty years have passed since a group of parents refused to accept the unacceptable and acted on their vision for a rich, inclusive, and fulfilling life for their children. TURN has grown to now serve over 725 individuals throughout the state, with a staff of nearly 500. I am thankful for kind-hearted, service-oriented employees and Board members who continue to carry forward our founders' vision. I am also grateful for the many donors who believe in TURN and help us meet essential needs and enrich the quality of life of people with disabilities in our community.

EMPLOYMENT SERVICES IN ACTION



"A student enrolled in TURN's Pre-Employment Transition Services was nearing the deadline for completing all his assignments on time for graduation. His Employment Specialist, Makenzie, had been contacted by his parents, asking if there was anything our program could do to help.

The student resisted offers of support from his parents and others to complete the necessary graduation requirements. The student's disabilities presented many barriers. He became quickly overwhelmed and withdrawn. Makenzie helped him divide large projects into smaller, more achievable goals. Concentration and organization were other barriers that prevented the student from being successful.


Our Pre-Employment Transition Services team worked diligently to teach the student soft skills, focusing on organization and concentration. These strategies were successful and put the student on the path to graduation.

The impossible suddenly seemed possible - the student turned all his work in on time, and graduation was now in his future. The high school was so impressed by the student's progress and success that they invited his Employment Specialist, Makenzie, to the graduation ceremony. The student continued with our Pre-Employment Transition Services program and obtained gainful employment in his chosen career field."

OUR STORY

Formerly known as Project TURN, we were founded in 1973 by a group of parents who wanted to improve program services for adult children with intellectual and developmental disabilities. TURN began by opening residential programs in Ogden and Bountiful. Individuals with disabilities could live in a traditional home setting, participate in community activities, and have an integrated, more independent social interaction experience.

More than forty years later, TURN Community Services now provides services to more than 710 individuals with developmental disabilities in Utah. We provide services across the state from Brigham City to St. George, UT. We offer a full range of services, including day programs, residential living services, art center programs, summer camps, and supported employment opportunities.




